In accordance with Art. 13 of Regulation (EU) 2016/679 (GDPR Cel Components S.r.l, as data controller, informs users of the processing of personal data resulting from the completion of this contact form.

### ***Data controller***

### ***Data subjects***

### ***Data processed***

Data processed are those entered in the contact form or identification data such as name and surname and contact details such as personal e-mail. Data collected are those strictly necessary in relation to the purposes for which they are processed, respecting the principle of 'data minimisation' enshrined in Art. 5 of the Regulation (EU) 679/2016.

Data provided will be processed by the controller in order to re-contact the user upon request.

### ***Purpose of the processing***

Personal data entered in the contact form, intentionally and voluntarily sent by the user, will be used to fulfil user's requests or the contact requested in the form itself. The information systems of this process rely on an e-mail protocol that guarantees the confidentiality and integrity of the information.

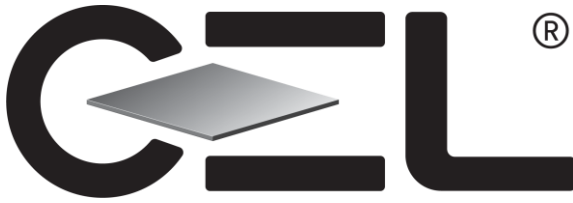
### ***Nature of the provision and legal basis of processing***

The legal basis for processing is Article 6(b) of Regulation (EU) 679/2016, which establishes that processing is necessary to take steps at the request of the data subject prior to entering into a contract.

### ***Processing modalities***

The data processing is carried out through digital procedures or telematic means and in paper form by internal or external subjects, specifically appointed, authorised, and committed to confidentiality. The data are processed and stored with instruments that guarantee security, integrity, and confidentiality through the adoption of appropriate measures as required by law.

### ***Data retention periods***

In addition, data may be communicated to the competent authorities, in accordance with the law.

***Personal data shall not be transferred to third countries outside the EU.***

### ***Rights of the data subjects***

Data subjects, at any time, have the right to access their personal data, to ask for them to be corrected, updated, and erased. It is also possible to object to the processing of personal data and request its limitation.
